Notice of Pre-AIA or AIA Status

1. The present application, filed on or after March 16, 2013, is being examined under the first inventor to file provisions of the AIA.

Allowable Subject Matter

2. Claims 1 – 2, and 4 – 20 are allowed.

The following is an examiner's statement of reasons for allowance:

The primary reasons for allowance of instant independent claims 1, 4, and 20 are the inclusion of the specific limitations regarding a sensor package including one or more sensors including at least one self-heated flux sensor configured to be heated to a temperature setpoint, in combination with a plunger assembly configured to hold the sensor package and a support base configured to provide physical support for the plunger assembly, and, with respect to claim 20, the specific limitation of clamping down the sensor package to the sensor holding unit by matching a portion of a sliding ramp with a portion of the sensor holding unit.

Sung discloses a temperature sensing device for an induction stove comprising a sensor package, a plunger assembly configured to hold the sensor package, and a support base configured to provide physical support for the plunger assembly, but fails to teach or disclose a self-heated flux sensor configured to be heated to a temperature setpoint, nor a sensor holding unit clamped down using a sliding ramp matched with a portion of the sensor holding unit. Sung's sole retention mechanism for securing the sensor module to the sensor installation unit is a push and rotate key/keyway/flange lock, which does not involve a sliding ramp.

Shigeoka teaches an induction cooker comprising a temperature sensor responsive to magnetic flux, wherein the temperature sensor self-heats due to exposure to the magnetic field of the heating coil. However, Shigeoka fails to teach or suggest a sensor configured to be heated to a temperature setpoint; rather, Shigeoka's disclosed structure positions the temperature sensor in a region of reduced magnetic flux density specifically to minimize self-heating, and the only temperature feedback and setpoint based control disclosed by Shigeoka is directed to regulating the temperature sensor itself. No structure is disclosed in Shigeoka by which the temperature sensor itself is driven toward a setpoint temperature.

No combination of the cited references teaches or suggest the claimed self-heated flux sensor configured to be heated to a temperature setpoint, nor the claimed sliding ramp arrangement for clamping down the sensor package and sensor holding unit, in combination with the other recited limitations of the independent claims.
