Notice of Pre-AIA or AIA Status

1. The present application, filed on or after March 16, 2013, is being examined under the first inventor to file provisions of the AIA.

Allowable Subject Matter

2. Claim(s) 1-17 and 20 are allowed.
3. The following is an examiner's statement of reasons for allowance:

In interpreting the currently presented claims, in light of the specification, the Examiner finds the claimed invention to be patentably distinct from the prior art of records.

Hooker et al. (US 11,467,675 B1) discloses multi-stage gesture recognition and conditional processing based on likelihood determination; however, Hooker does not disclose or suggest the claimed hierarchical detector architecture explicitly defining different gesture-set scopes tied to qualified power consumption levels and selective invocation based on gesture classification scope. Specifically, Hooker does not clearly disclose performing an action based solely on low-power detection without invoking higher-power processing. Accordingly, the claimed invention as a whole is not anticipated by, nor rendered obvious over Hooker.

Schick et al. (US 2021/0342002 A1) disclose a wearable tap detection system that switches between lower and higher power modes upon detecting a tap event using mechanical sensors. However, Schick does not disclose a wearable device configured to process neuromuscular signals to detect in-air hand gestures using dual detector architecture in which a low-power detector detects a second set of in-air hand gestures, a high-power detector detects a broader first set of in-air hand gestures, the second set includes fewer gestures than the first set, and certain gestures are detected and acted upon using only the lower-power detector without invoking the high-power detector.

For these reasons, the Examiner believes the limitations indicated above and in combination with the rest of the limitations are allowable over the prior art of record.
