DETAILED ACTION

1. This Office Action is in response to the filing of September 29, 2023. Claim(s) 1-52 is/are pending and have been considered as follows.

Notice of Pre-AIA or AIA Status

2. The present application, filed on or after March 16, 2013, is being examined under the first inventor to file provisions of the AIA.

Information Disclosure Statement

3. The information disclosure statement (IDS) submitted on 11/27/2023, 3/28/2024, and 1/13/2025. The submission is in compliance with the provisions of 37 CFR 1.97. Accordingly, the information disclosure statement is being considered by the examiner.

Allowable Subject Matter

4. Claim(s) 1-52 is/are allowed.

5. The following is an examiner's statement of reasons for allowance:

In interpreting the currently presented claims, in light of the specification, the Examiner finds the claimed invention to be patentably distinct from the prior art of records.

Yu et al. (US 2022/0240151 A1) discloses a LEO satellite communication system is in communication with a first setting satellite having a first field of view including a first plurality of cells, and a second rising satellite having a second field of view including a second plurality of cells. The first and second satellites have an overlapping field of view having an overlapping plurality of cells located therein. A first processing device has a first communication port communicating with a first cell of the first plurality of cells via said first antenna over a first beam, and a second communication port communicating with an overlapping cell of the overlapping plurality of cells via said second antenna over a second beam. Said first processing device switches from said first communication port to said second communication port in response to the first cell of the first plurality of cells moving into the overlapping field of view.

Yao et al. (US 11,121,764 B2) discloses a satellite communications system, a base station communicates with standard compliant user equipment (UE) via a satellite having a field of view. The base station has a processor that instructs the satellite to generate a wide beam signal covering a plurality of cells in the field of view, and detects an access request from a user equipment within the plurality of cells over the wide beam signal. The base station, comprising a processing device such as an eNodeB, then generates one or more network broadcast/access signals that is uplink to a satellite and broadcasted via one or more nominal beams generated by the satellite, covering all the inactive cells, one of the plurality of cells having the access request.

Ravishankar et al. (US 11,483,877 B2) discloses a user terminal (UT) for a mobile satellite communications system, and an associated method for managing tracking areas for such a UT is provided. When initiating establishment of a radio connection, the UT transmits a connection request message to a satellite gateway (SGW) of the mobile satellite communications system, where the connection request message includes position information

identifying a current location of the UT. The UT processes a connection setup message received in response to the connection request message, where the connection setup message includes a first tracking area identifier (TAID) that identifies a one of a plurality of tracking areas that is associated with the current location of the UT. The UT transmits a connection complete message to the SGW, together with an attach request message for a core network of the mobile satellite communications system, which includes the first TAID.

Su et al. (US 2019/0098381 A1) discloses method and a transmission device are disclosed the method includes: mapping n client signals with a rate of t to ms/t load subareas of m lanes of flexible optical transport network (FlexO) frames, where a payload area of each of the m lanes of FlexO frames is divided into s/t load subareas, and each lane is transmitted using a FlexO lane with a transmission rate of s ; configuring a FlexO type, timeslot overhead, and signal mapping information for each lane; and transmitting the m lanes of FlexO frames to a second transmission device by using m FlexO lanes with the transmission rate of s . The second transmission device is configured to parse, according to the FlexO type, the timeslot overhead, and the signal mapping information, the client signals carried in the ms/t load subareas.

The prior art of record does not disclose or suggest either singly or in combination receiving, from a first satellite of the plurality of satellites, connection data indicating that a first UE has connected to the RAN via a first beam of the first satellite, wherein the connection data identifies a physical localized identifier of the first beam and a connection time; determining, from a mapping of physical localized identifiers to virtual localized identifiers across a plurality of time slots, a first virtual localized identifier associated with the physical localized identifier of the first beam and the connection time, the first virtual localized identifier corresponding to a first of the geographic sub-areas; and in response to the determining, causing to be stored location data for the first UE indicative of the first geographic sub-area.

For these reasons, the Examiner believes the limitations indicated above and in combination with the rest of the limitations are allowable over the prior art of record.
